

NORTH EAST TOWNSHIP SUPERVISORS
MEETING
MONDAY, JUNE 3, 2019
7:30 PM

Chairman Robert Mazza called the meeting to order with the Pledge of Allegiance. Also, in attendance were Supervisors August Neff, Fredrick Shunk, Attorney Robert Jeffery and Secretary Karen Ahlgrim. Members of the public included Jim Barbour, Nick Bruno, Jim Williams, Nick Mobilia, Barbara Clark, Harry Clark, Anna & Hugh McCartney, Teresa Sculley, Matt Putman, Kathie Mazza and Kim Lux.

Chairman Mazza asked for public comments or concerns and none were received. A motion from August Neff and the second from Robert Mazza approved the minutes of the May 20th, 2019 meeting as presented and passed by unanimous vote. Secretary Karen Ahlgrim presented the Treasurer's report for the month of May 2019 and by a motion from Fredrick Shunk and the second from Robert Mazza was accepted as presented and passed by unanimous vote. Bills were presented for May 20th through May 31st, 2019 for approval and payment as follows:

Total approved by a motion from Fredrick Shunk and the second from Robert Mazza was \$425,251.87 and passed by unanimous vote.

Mr. Nicholas Bruno addressed the Board with some informal information about a system to recycle glass of all colors (separated) at a type of pop-up recycling area. It is a streamlined process turning waste glass into furnace ready cullet & new glass aggregate commodities. The project will need a 9-month trial and he is seeking different areas of Erie County to help. The company will be called Flagship Glass and located at 12th & East Avenue in Erie, it will be a low- cost facility, eventually providing 10-20 jobs. These will be no cost drop-off points; a pickup service is being considered for businesses. They will be asking for municipal public-private partnerships for locations to place the pop- up, advertising aid, and volunteer labor to help educate the public. They already have many partnerships, like Millcreek Township, Gannon University, Erie County and Erie City Governments. Several guests made comments about the importance of glass recycling. At the end of his presentation Mr. Bruno asked if the Township would be interested in signing a letter of intent to support the collection of the waste glass at specified locations on specified dates and to help promote the program.
